We're responding to your request dated Jan. 02, 2024, about RESEARCH TRIANGLE INSTITUTE.

According to IRC Section 6033(j), if you don't file a required annual information return or notice for 3 consecutive years, we'll revoke your tax-exempt status on the due date of the 3rd required return or notice.
