

#### Feed the Future Liberia Food Security, Nutrition, and Resilience activity

#### **Annual Program Statement (APS)**

Call for Concept Papers to support activities to improve production, post-harvest processing, storage, and provision of small irrigation systems in selected counties in Liberia.

Feed the Future Liberia Food Security, Nutrition, and Resilience activity is a 5-year project with the overall goal to increase agriculture-led economic growth through improved production and productivity to enhance food and income security as well as improve nutritional well-being among targeted communities. The activity was awarded to RTI International in partnership with BRAC, Dimagi, and GiveDirectly. FSNR is designed to increase rural economic development and food security in Liberia through: (1) strengthening agricultural practices and capacity for on-farm processing among targeted groups; (2) diversifying livelihoods and increasing incomes through access to finance, assets, and agricultural equipment; and (3) improving market access and year-round availability of nutritious foods among targeted communities and households.

The overall purpose of the activity's "Resilience Investment Fund" (RIF) is to support eligible cooperatives as well as Small and Medium Enterprises (SMEs) in improving production and post-harvest food processing and storage, along with small-scale irrigation infrastructure in Montserrado, Margibi, Bong, Nimba, Grand Bassa and Lofa. Through the RIF, the cooperatives will progressively take on responsibility to sustainably provide services to their members.

FNSR has identified categories of nutritious foods with potential for increased demand and supply. FSNR has consulted with the Ministry of Agriculture and other stakeholders on prioritizing the selected nutritious foods to determine the value chains FSNR will promote over the life of the activity. The selected foods are locally produced and consumed in the country and were selected based on their nutrient values. Grants funded in this round will focus on the production, processing, and marketing of cowpeas, maize, poultry (meat and eggs), orange-fleshed sweet potatoes, peanuts, production and/or processing of poultry feeds, and vegetables (cabbage, cucumber, and okra).

Final funding levels will depend on number and quality of viable applications received, availability of funding, suitability of the application in line with scope of FSNR activity and USAID priorities. Grants will be awarded competitively in amounts commensurate with their impact but shall not exceed the maximum amount of USD 100,000 and within an implementation period of 12 -24 months from date of award.

#### **Section I. Illustrative Partnership Activities**

The Feed the Future Liberia FNSR activity will consider activities that directly contribute to the achievement of the activity's goal to increase agriculture-led economic growth through improved productivity to enhance food security and nutrition, specifically for the following foods: rice, maize, cowpeas, poultry (meat and eggs), orange-fleshed sweet potatoes (OFSP), Cassava, peanuts, avocado, moringa, pawpaw/papaya, and vegetables (cabbage, cucumber, and okra).

FSNR seeks concept notes for grant funds to provide established cooperatives, and Small and Medium Enterprise (SMEs) support for the following illustrative activities:

- Promotion of small and medium scale poultry farming (for eggs and/or poultry);
- Collaborate with local small and medium enterprises or poultry farmers to scale up production of poultry (for eggs and/or poultry);
- Promote production, processing, and consumption of nutritious foods in rural communities and peri urban areas.
- Innovative technologies to improve production, processing, storage and marketing of vegetables and fruits ,including okra, pepper, etc.
- Commercial production of orange flesh sweet potatoes to improve the availability and consumption of orange flesh sweet potatoes
- Increase production, processing, and consumption of groundnuts.
- Reduce post-harvest losses of nutritious and staple foods
- Recycling of organic waste and technologies that contribute towards reduction of carbon emission
- Enhance the marketing of nutritious and staple foods

Through the Resilience Investment Fund (RIF), the FSNR activity seeks to not only support groups with access to inputs, equipment, and technologies to improve production, enhance productivity and diversify processing of nutritious and staple value chains , but also reinforces the Sustainable Farmer Group Approach by strengthening resilience of farmer groups, women's groups, youth groups, and cooperatives to gradually take on greater responsibility for procuring goods and services to support their members.

Like all capacity-building initiatives, the grant awards will be contingent upon the recipient's existing capacity. Moreover, the possibility of receiving additional awards hinges on the successful execution of previous grant allocations.

Applications can include more than one of the above-mentioned activities.

RTI and its partners will play a facilitative and coordination role in implementing the activity through private sector firms, cooperatives, and village savings, and microfinance institutions. In playing the facilitative and





coordination roles, RTI may collaborate with other agencies depending on feasibility of anticipated level of synergies with implementing agencies to provide support to the eligible cooperatives and SMEs.

#### Please note that Liberia FSNR grant funds will not be used to support any of the following:

- i. Construction costs <u>purposes</u> except for installation of irrigation facilities or any low-cost appropriate technology used for irrigation. Irrigation facilities may be solar-powered or include a small battery-operated pump.
- ii. Vehicles including cars, motorbikes, trucks, tractors.
- iii. Salary for the cooperative members or business owners
- iv. Purchase of chemical fertilizer, pesticides and or any environmentally harmful products.
- **v.** Purchase of secondhand goods or used machinery. New agricultural machinery and equipment are eligible for funding.
- vi. Any activity that is considered illegal according to the laws of Liberia

#### Section II. Co-investment

Co-investment is required under this APS at a minimum of 1:1 match in private funding. Priority will be given to applicants that can provide a co-investment to their requested budget. Applicant's contributions can be in the form of cash (such as private capital or loans), infrastructure, property, equipment, new and existing staff working on the requested grant activities, and others directly used for the proposed activity. Standard operational costs will not be considered as part of the contribution.

The Resilient Investment Fund (RIF) intends to leverage group co-investment in all the proposed activities, with 50% co-investment requirement for support towards the rehabilitation of irrigation facilities and/or procurement of new low-cost appropriate irrigation technology, including solar irrigation pumps with all its required accessories.

The applicant can propose mobilization of additional financial resources, such as equity or debt that will come from other sources including, formal financial institutions such as commercial banks, individuals, other companies, funds, and foundations, and bilateral or multilateral organizations.

These co-investments are uniquely secured and cannot be sourced from the funding of other donors. They represent a dedicated commitment to our specific initiatives and objectives, ensuring that the resources and support required for our projects are distinct and independent, further reinforcing our determination to achieve our goals.

A detailed budget is not required for the concept note stage of this APS. However, applicants are required to provide a summary of the <u>total activity budget showing the amount of co-investment contribution from the applicant and the amount of grant funding requested from RTI</u>. Successfully evaluated concept notes, if invited to respond to the Request for Applications (RFA), will be required to submit a detailed budget and narrative.

Based on applications, the first round of evaluations is anticipated after October 7, 2024. The second round of evaluation will occur after October 31, 2024.

#### **Section V. Type of Awards**

Grants awarded under this APS will primarily be Fixed Amount Award grants (FAA) or hybrid FAA that includes FAA and in-kind grant

Under FAA grants, RTI will make payments based on submission and acceptance of specific verifiable milestones. Once an award is issued, it will include a fixed price payment schedule with milestones and deliverables negotiated during the final application and award process.

#### **Section VI. Unique Entity Identifier (UEI):**

Beginning April 4, 2022, the Unique Entity ID (UEI) from SAM.gov is the authoritative identifier for those doing business with the US Federal government. The Unique Entity ID is generated in SAM.gov (www.sam.gov).

Whereas applicants can submit their Concepts applications without the UEI number. However, grant recipients must provide the UEI before they can receive any funding. Due to delays in processing of UEIs, applicants are encouraged to apply for the number early.
